CHRIST LUTHERAN CHURCH ANNUAL MEETING MINUTES FEBRUARY 6, 2022

The meeting was called to order by President Mark Turany at 9:05 am. A quorum was reached with members present both in the sanctuary and the church parking lot due to pandemic concerns.

Opening devotions were led by Pastor Rheingans.

A motion was made by Debra Fugleberg to approve the minutes from the last meeting. The motion was seconded by Jeanne Tweite.

Reports: Pastor Rheingans and Pastor Nirmala gave their reports to the congregation. Jason Pfeilsticker gave the Treasurer's report. Income exceeds expenses for the year by \$32,617.65

Election Ballot: Brent Hoegh motioned that we cast a unanimous vote and was seconded by Dave Tweite. Motion carried.

Approval of the Budget: Jason Pfeilsticker presented the budget. Dave Tweite motioned that we accept the budget as presented and was seconded by Amy Blank. Motion carried.

New Business: Discussions were held regarding the roof replacement, which needs to be done this summer. The roof was damaged in December because of severe weather. It has been temporarily fixed and a claim has been filed with the insurance company. Until we find out what the insurance company will pay, our exact cost is unknown. Several motions were presented so that we will be able to proceed with the replacement.

Bob Brekke motioned that we move up to \$60,000 from the General Fund to the Roof Fund at the time necessary. Joe Biewer seconded the motion. Motion carried. Mark Polzin motioned that we authorize up to \$180,000 for roof repair, which is to come from the Roof Fund. Susan Holz seconded the motion. Motion carried. Irv Nehring motioned that we authorize a loan from the bank of up to \$50,000 for the repair of the roof. Julie Carblom seconded the motion. Motion carried.

A motion was made by Nancy Hoegh that we adjourn the meeting and was seconded by Candee Ostreng.

Pastor Nirmala gave the closing blessing and closed with the Lord's prayer.

A highlight of this past year was Owen Hoegh's ordination. We miss Owen and his family but are grateful to have walked with them towards his ordination. Blessings to Owen and his family as they serve at St Paul's Lutheran Church of Hull Iowa!

The roof project has been hanging over our heads for the past few years with a wide range of estimates. Due to the December 2021 windstorm, insurance monies and monies saved in the roofing fund, we did not need to borrow for the roofing project. Thanks for your generosity!

In the past two years 6 families that gave more than \$4,000 per year to the general fund transferred to other churches, moved, or died. The following numbers are totals from the top 3 lines on our Step Giving Chart to be found later in this annual report on page 19.

2020 19 families gave 124,634 124,634 2021 18 families gave 113,465 2022 13 families gave 81,560 <u>81,560</u> -43,604

Our offerings were down around 25,000 in 2022. Thankfully we had new givers and others who increased their giving. The last two years we received federal Covid related money to help us finish the year better than we started.

I encourage you to prayerfully consider what percentage of your income you give to Christ Lutheran. A thousand years from now I am convinced that you won't be wishing you had given 1 percent instead of 3 percent of your annual income to the mission of God through Christ Lutheran Church. You can gain insight into CLC's giving trends by looking at the Step 4 Year Giving Chart on p19 in this annual report.

2022 was a year we were able to fully eliminate the covid guidelines that were in place. It was so nice to see no masks and pews filling up again. We continued with our 3 options of worship, in person worship, parking lot service with the FM broadcast, and You Tube online worship. EDUCATION

Sunday School for ages 3 year olds- 6th grade continued at Christ Lutheran Church with the help from volunteers to facilitate the program with 87 kids enrolled. The classroom education teams consist of an

adult volunteer teacher and a confirmation student helper when available. Teacher orientation was completed on September 7th. This fall we held a "Carnival" at the church to kick off Rally Sunday and to start the Sunday School year. Games, snacks, and prizes were awarded to those who participated. Our Sunday School curriculum is "Foundations Of Faith" by Group Publishing. Adult Education was offered on Sundays in between services this year.

A family retreat with snow tubing at Steeplechase was planned. This was canceled due to the early warm weather we experienced. The annual Easter Egg Hunt was held outside on April 10th and the kids were divided into 2 groups. Vacation Bible School was held in the evenings on August 1st-4th with the theme "Discovery on Adventure Island". The kids participated in music, games, snack, lesson, science activity, and crafts. There were 28 kids that registered for VBS.

This fall 7 kids from 3rd grade received their own bibles from CLC during the worship services on September 18th. On October 30th, there were 13 students who received 1st communion. The 5th graders had four in person lessons during their Sunday School classes prior to receiving 1st communion. The participants made communion bread with their class and then met as a group with their parents where they discussed their project on what communion means to them. The projects were displayed in the narthex on First Communion Sunday.

The Children's Christmas program was on December 11th during the 10 AM worship service. The play was "The Backwards Christmas Pageant". Children in grades 4-6 were offered a speaking role/costume part and music was provided by all kids in Sunday School.

Confirmation classes are held on Wednesday evenings for students starting in 7th grade. There were 15 students who were confirmed in the spring. This year, the 7th grade class has 12 kids and the 8th grade class has 20 kids participating in the confirmation program. The students continue with lessons from Pastor Steve or Pastor Nirmala each week followed by discussion and small group time with their mentors. The students are also assigned a worksheet and a bible reading to do as homework prior to each class. Each student is required to complete 12 sermon notes and 3 service projects each year. They are also scheduled to acolyte during worship on a scheduled basis during their confirmation years. The families are easily able to stay informed through weekly confirmation emails from the coordinator. Confirmation students helped with the Lenten meals again in 2022.

WORSHIP AND MUSIC

Lent/Easter Season:

Lent: Ash Wednesday was on March 2. The theme for Lenten services this year was "Voices Around the Cross", a drama series of lay people from CLC representing those people who were affected long ago by the death of Jesus on the cross. These dramas were supplemented with "The Holden Evening

Prayer" service. Soup suppers were offered starting on March 15 when the Covid restrictions at CLC were lifted. The Youth Committee used pre-packaged soup mixes, crackers, and pre-packaged cookies for the suppers. Each church committee donated \$70 to cover the cost of the meal instead of providing the traditional soups and bars/cookies. Youth and adults serving food wore masks.

Holy Week: Maundy Thursday and Good Friday services were held at 6:30. There were 3 services on Easter Sunday---7:30/9:00 (traditional) and 10:30 (blended).

Christmas Services: The Sunday School Christmas program was held on December 11 at the 10:00 service. The Cantata service, "Together at Christmas", was the week after, December 18, at both services. Christmas Eve candlelight/communion services were offered at 3:00, 4:30, and 7:00. One service on Christmas Day was held at 9:00. Battery candles were used at all the candlelight services (150 new ones ordered). New Year's Day service on January 1 was at 9:00.

Youth Tone Chimers: Kids interested in playing tone chimes started practicing after Christmas and then played in church in early March.
