COUNCIL PRESIDENT'S REPORT MARK TURANY

2023 we saw a strong increase in our in-person worship. We went from 151 in 2022 in person worship to 175 in 2023 in person worship. We also continued with our 3 options of worship, in person worship, parking lot service with the FM broadcast, and You Tube online worship. We stayed focused in our mission together in "Equipping all ages to lovingly serve God and people" by the way of our vision statement of "Making Christ's Love Known". This work was again carried out by all our great committees, volunteers, staff, and Pastors' work.

Financially for 2023 we saw an increase of giving over last year by \$17,000, thank you to everyone that gave in 2023! Unfortunately, we ended the year with a loss of \$11,704 giving to expenses. This was due mainly to increases in staff wages and maintenance projects needing to get done.

We have a total of 322 giving units (giving units = families or single givers) and 234 of those units gave in 2023. For 2024 expenses will remain or increase again due to inflation. We will need to see another increase in giving this year to make ends meet. Please review the 2023 Step giving 4 year report to see where you landed and please prayerfully consider an increase for this year.

Thank you to all that gave treasure, time, and talent this last year.

Thank you to the many volunteers, committees, and staff for all their work to keep our mission moving forward and to holding expenses as low as possible.

Thank you to the members of the Church council for their work this year and the support they gave to the committees and Pastors.

Pastor Steve is our Spiritual leader, guide, and teacher. He is so involved in everything that happens at CLC. He has unending love, kindness, and caring that he shares everyday with us. Thank you, Pastor Steve!

Pastor Nirmala continues to support Pastor Steve, lead us in worship, inspires members to be good stewards and get involved in what CLC does. Thank you, Pastor Nirmala for all you do for CLC.

This coming year as we do each year, we want to continue our work and outreach within our community, so they know we are here for a great place for fellowship and worship.

EDUCATION COMMITTEE

Sunday School for ages 3 year olds-6th grade continued at Christ Lutheran Church with the help from volunteers to facilitate the program with 92 kids enrolled. The classroom education teams consist of an adult volunteer teacher and a student helper when available. Teacher orientation was completed on Sept 6th. This fall we held our second annual "Carnival" at the church to kick off Rally Sunday on Sept 10th and to start the Sunday School year. Games, snacks, and prizes were awarded to those who participated. Our Sunday School curriculum was changed to lessons from Spark Lectionary Curriculum to follow the church calendar lessons. Adult Education was offered on Sundays in between services this year.

In March, we hosted a pizza and puzzle event. This was free and open to the public. We had a successful turnout and childcare was provided by the confirmation students. The annual Easter Egg Hunt was held outside on April 2nd and the kids were divided into 2 groups for the egg hunt. Vacation Bible School was held in the evenings on July 31st-August 3rd with the theme "Camp Kilimanjaro". There were 50 kids who participated in music, games, snacks, lessons, and crafts.

This fall 13 kids from 3rd grade received their own bibles from CLC during the worship services on Sept 17th. On October 29th, there were 14 students who received 1st communion. The 5th graders had four in person lessons during their Sunday School classes prior to receiving 1st communion. Participants made communion bread with their class and then met as a group with their parents where they discussed their project on what communion means to them. The projects were displayed in the narthex on First Communion Sunday.

The Children's Christmas program was on December 10th during the 10 AM worship service. The play was "The Very Important Christmas Pageant". Children in grades 4-6 were offered a speaking role/costume part and music was provided by all kids in Sunday School.

Confirmation classes are held on Wednesday evenings for students starting in 7th grade. There were 19 students who were confirmed on April 23rd. This year, the 7th grade class has 18 kids and the 8th grade class has 13 kids participating in the confirmation program. The students continue with lessons from Pastor Steve or Pastor Nirmala each week followed by discussion and small group time with their mentors. Each student is required to complete sermon notes and service projects each year. They are also scheduled to acolyte during worship on a scheduled basis during their confirmation years. Confirmation students helped with the Lenten meals again in 2023.

WORSHIP AND MUSIC COMMITTEE

Lent/Easter Season:

Lent: Ash Wednesday was on February 22, 2023. The theme for Lenten services this year was "Stories of Faith". Each week a CLC member prepared a 10-12 minute talk on 1) how God/faith got him/her through difficult times, 2) how his/her personal faith made a difference at work, 3) what key chapters, moments, or people helped him/her grow in personal faith. The four speakers were Sue Briske, Sandy Erickson, Kristine Ihrke, and Matt Petersen. These inspiring stories of faith were followed up with questions from Pastor Steve and were well received by the congregation. The Holden Evening Prayer Service was used in conjunction with the faith stories every week.

Holy Week: We had Maundy Thursday, April 6, and Good Friday, April 7, services at 6:30 both evenings.

Easter Sunday: We had 2 services on Easter Sunday at 8:00(traditional) and 10:00 (blended).

New Sanctuary Lighting: The new lighting for the sanctuary was upgraded in January by replacing light bulbs with brighter LED's and redirecting many of the spot lights. Many of the spot lights had changed position because of the new shingles so the money for the new light bulbs came from the roofing fund.

George Jamsa Scholarship Update: The scholarship form was updated making it easier for applicants to fill out. Also, an article to familiarize the congregation who might not have known George Jamsa was sent out in the weekly emails and monthly newsletters so people could learn George's many contributions to the music program at CLC, the purpose of the scholarship, and how people could donate to the scholarship fund if interested in doing so. The application and explanation have been posted online.

Summer Service Times: Starting Memorial Day weekend and ending Labor Day weekend, CLC went to a single 9am service throughout the summer. Services alternated between traditional and blended.

New Video Card: A new video card was purchased for the sanctuary computer for \$400. This amount was paid for from our budget. Thank you to Mark for overseeing this purchase.

Song List Update: Julie updated the list of songs that have been used at CLC services over the last 4 years. This list is also used for reporting our music streaming usage to CCLI and One License. Thank you to Julie for undertaking this large update.

Christmas Eve and Day Services: Because Christmas Eve fell on a Sunday, there was a 9:00 AM service on December 24. Christmas Eve services were at 3:00, 4:30, and 7:00. There was no Christmas Day service. There was a 9:00 AM service on Sunday, December 31.

Thank Yous: There are so many people who tirelessly contributed to the worship and music ministry at CLC this year, and our committee sincerely wishes to thank them.
